RULES / INSTRUCTIONS

- Students should behave in an orderly, disciplined and dignified manner in the institute campus/hostel premises/in public.
- Student to carry Identity Card issued by the institute all the time and the same should be produced on demand by concerned
 Person / Authority.
- Wearing of prescribed uniform mandatory for students on all working days and during practical training / technical visits.
- Ragging in the institute / hostel is strictly prohibited.
- Library books will only be issued on production of libary cards by the Institute.
- Institute, Library & Hostel rule shall be impose strictly to defaulters who are liable for penalty as per respective rules.
 Due Care of Institute/Hotel property shall be taken by users including laboratories, fire appliances, equipments and allied
- items.
- Students will have to pay for repair / replacement of the Institute / Hostel property damaged or lost due to their carelessness.
- Smoking, Chewing of tobacco, gutkha and alcoholic drinks are strictly prohibited in the college campus, hostel and in public.
 Any change of address must be informed in writing to the Institute office.

- At the time of taking admission and during subsequent academic semesters each and every student would be required to

- The number of seats & courses are designed according to the training/ coaching facilities available.
- Admission to the specific course/ discipline shall be granted strictly as per the norms and rules of the management committee which shall be final & binding on all concerned.
- The management reserves the right to revise the syllabus, Institute timing or course duration if found necessary by authority.
- Admission to the specific course/ discipline shall be granted strictly as per the norms and rules of the management committee which shall be final & binding on all concerned.
- The admission of the student is deemed to be cancelled if he/she remains absent for 5 days or more without prior permission from the competent authority of the Institute. Subsequent continuation will be treats as fresh admission.
- The original Certificates/ Documents will remain keep with the college till the completion of the courses or till the withdrawal formalities have been complete.
- 75% attendances are compulsory irrespective of theory, practical and drill in all subject to become eligible for appearing examinations.
- Any matter not governed by the rules and regulation given in this prospectus, shall be suitably framed by the management as and when need arises which shall be binding on all concerned with retrospective effect.
- The student will have to appear for the entire periodic test & complete all assignments / presentations/ tasks given to him for the purpose of Internal Assessment. Student will be eligible for the examination only if he or she secures minimum 60% marks in the internals.
- Student found violating the rules may be disallowed to continue and his/her the admission can be cancelled without any clam of the fee paid.
- The institute reserve the right to update the programs through the changes in schedule, methodology, contents & structure from time to time, as and when needed.
- Students are required to observe the decorum while attending the Academic program.
- · Placement Assistance is subject to individual performance of students in theory, practical and interview.
- Student should well acquainted with the fact that institute is not providing guarantee for placement. Institute will work as a

- Institute will not be responsible for those students who are living in private hostels and rooms outside college premises.
